Trials

Trials for the 2009 Program will be conducted on **Saturday 14th March 2009.**

Trials will be held at Bossley Park High School, Prairievale Road, Bossley Park..

Trial details are:

1995-1996 born	3:15pm – 4:45pm
1992-1994 born	5:00pm – 6:30pm

Program

The program consists of the following:

Easter School Holidays Live-in Camp (3-night camp; Mon 13th – Thurs 16th April)

Term 2 – one session per week (Fairfield Road Park, Guildford)

Term 3 – one session per week (Fairfield Road Park, Guildford)

October School Holidays Live-in Camp (4-night camp; Sun 4th – Thurs 8th Oct.)

Term 4 – three sessions per week held on one day

The camps are held at Chevalier College, Bowral.

The program consists of 65 sessions not including the sessions at the Easter Camp.

The Easter Camp sessions are free of charge as they form part of the trial process.

These coaching costs are covered by IQ Football.

Training Schedule – Term 2 & Term 3

Term 2 - 3rd, 10th, 17th, 24th, 31st May. 7th, 14th, 21st, 28th June 5th July

Term 3 - 2nd, 9th, 16th, 23rd, 30th August. 6th, 13th, 20th, 27th September

Term 4 Dates - TBA

Term 4 usually consists of three sessions held concurrently on a Saturday *or* Sunday.

This reduces the amount of travel and hence inconvenience for the parent and the child. It has proven to be successful over the past two years.

Program Costs

IQ Football continues to work towards reducing fees. 2007 fees were \$1590 and 2008 fees were \$1250. The 2009 fee represents close to a 25% reduction within a 2 year period.

The cost of the program is:

2000 born - \$900 *

1992-1999 born - \$1200

* (excludes the camps. If a 2000 born player is deemed confident enough to attend camp then it is an additional \$300 for this player).

The camps form an integral part of the IQ Football development process as players are able to develop the important off-field traits of a footballer such as self-discipline, organizational & social skills, character & self-confidence.

The camp costs are:

Easter School Holiday Camp - \$330 **

October School Holiday Camp - \$440 **

These costs take into account hire of the facility, accommodation, continental & cooked breakfast, morning tea, lunch, afternoon tea, dinner and supper.

** These costs have not changed in 4 years. However, they may be subject to a slight increase due to Chevalier College costings.

Payment Plan

The program cost can be paid in installments as follows:

Installment 1 : \$500 Due Sunday 25th May 2009

Installment 2 : \$400 Due Sunday 2nd August 2009

Installment 3 : \$300 Due Sunday 1st November 2009 ***

*** Not applicable to 2000 born non-campers
